

Blazor for Kids Framework License Agreement

This License Agreement ("Agreement") is made and entered into by and between Elgibe Solutions SRL ("Licensor") and the individual or entity ("Licensee") purchasing a subscription to the Blazor for Kids framework. By purchasing and using the framework, the Licensee agrees to be bound by the terms of this Agreement.

1. License Types & Permissions

Licensor offers the following subscription plans with the respective rights and responsibilities:

1.1 Personal Use License

- Rights:
 - Access to comprehensive documentation and code samples, to the extent made available by the company.
 - Free updates and new features for one year.
 - Free access to exclusive webinars, in the terms and conditions prior agreed with the company..
 - o Unlimited lifetime usage of the current framework version.
- Restrictions:
 - No commercial license is granted.
 - Licensee **may not** use the framework to create or sell applications.
 - License is non-transferable and intended for personal educational purposes only.
 - The user undertakes to acknowledge and respect the company copyrights arising from the company's ownership of the license.
 - The user agrees to act fairly and in good faith when expressing opinions about the license or the company's products. In case of dissatisfaction, the user is encouraged to first seek an amicable resolution by contacting the company directly.

1.2 Freelancer License

- Rights:
 - Access to comprehensive documentation and code samples.
 - Free updates and new features for one year.
 - Priority email support.



- Unlimited lifetime usage of the current framework version.
- Licensee **may** create and sell applications using this framework.
- Restrictions:
 - o Licensee may not sublicense, resell, or redistribute the framework itself.
 - Licensee is responsible for compliance with any third-party dependencies used in their applications.
 - The user undertakes to acknowledge and respect the company copyrights arising from the company's ownership of the license.
 - The user agrees to act fairly and in good faith when expressing opinions about the license or the company's products. In case of dissatisfaction, the user is encouraged to first seek an amicable resolution by contacting the company directly.

1.3 Small Business License

- Rights:
 - All benefits of the Freelancer License.
 - Priority email support for the development team.
 - Option to request custom feature development (subject to separate negotiation and fees).

• Restrictions:

- Licensee **may not** sublicense, resell, or redistribute the framework itself.
- Licensee must comply with all applicable laws regarding software development and licensing.
- The user undertakes to acknowledge and respect the company copyrights arising from the company's ownership of the license.
- The user agrees to act fairly and in good faith when expressing opinions about the license or the company's products. In case of dissatisfaction, the user is encouraged to first seek an amicable resolution by contacting the company directly.

2. Subscription & Renewal

- The license is valid for **one year** from the date of purchase, and includes both the date of purchase and the end date.
- Renewal is required for continued access to updates, support, and new features.
- Licensees with an active subscription retain access to the latest framework version.
- If the subscription is not renewed, Licensee may continue using the latest downloaded version but loses access to future updates and support.



3. Intellectual Property Rights

- The Blazor for Kids framework and all associated materials remain the intellectual property of the Licensor. The agreement between the parties does not entail the transfer of any copyright, trademark, or other intellectual property rights to the user.
- Licensee is granted a **non-exclusive**, **non-transferable** right to use the framework under the terms of the selected subscription.
- Licensee **may not** claim ownership of or distribute the framework as their own.

4. Prohibited Uses

- Licensee may not reverse engineer, decompile, modify, or distribute the framework in any way beyond the rights granted in this Agreement.
- Redistribution of the framework, whether modified or unmodified, is strictly prohibited and may result in legal action, as well as claims by the Licensor.
- Licensee **may not** share their license credentials with third parties.

5. Warranty & Liability

- The framework is provided "as is" without warranties of any kind, express or implied.
- The Licensor is not responsible for any damages, losses, or liabilities resulting from the use of the framework.
- The Licensor does not guarantee uninterrupted or error-free operation of the framework.

6. Termination

• This Agreement shall be governed and construed in accordance with the laws of Romania.



• Any disputes arising under this Agreement shall be resolved through arbitration in Romania, at the International Commercial Arbitration Court attached to the Cluj Chamber of Commerce and Industry.

• The Licensor reserves the right to update this Agreement at any time. The Licensees will be notified of significant changes.
